In consideration of my acceptance to membership and intending to be legally bound by this document and on behalf of myself and any minors in my custody or control, I assume sole responsibility for the safety of my/our person and property while I am at the property of The Woods Campground, Inc. I acknowledge by signing this waiver that I am entering a campground with limited improvements and I am here for the express purpose of enjoying the rustic outdoor environment. I understand that the paths and roadways are unpaved, that the swimming pool is shallow and unattended by a lifeguard or other personnel and there are no security guards on the property. Any of the above and other conditions on the property may pose a risk of injury, including serious physical injury, economic losses, permanent disability or death. I acknowledge by signing this waiver and release that I am waiving my rights to hold the owners or employees of The Woods Campground, Inc. liable for any of these injuries that I may sustain either as the result of my own action or omission or by engaging in any sport or activity either alone or with other persons who may be at the campground. I waive any claim at law or equity which might arise and I bind my/or heirs, executors or administrators to this agreement. I further agree to save harmless and to reimburse the owners of The Woods Campground, Inc. for any award or verdict for damages, as well as counsel fees it incurs, in connection with any suit or judgment which may result from said suit caused by my own actions or omissions. I understand that The Woods Campground, Inc. is an "alternative" campground catering to gay and lesbian clientele and I am not offended by gay or lesbian patrons. I understand that The Woods Campground has no responsibility to inform any guests or visitors of the nature of its patrons. I agree to follow all of the Rules and Policies of The Woods Campground, Inc., having acknowledged receipt of a copy of those Rules. I understand that any violation of the Rules or Policies could result in a revocation of my membership. I will not participate in any illegal activity. Membership dues are non-refundable. Membership is good for one camping season. The Woods Campground hereby assigns to the member signing this Application the right to utilize the access road to its property, which access crosses the property of Suzanna Vaughn, on a non-exclusive basis for the term of this Campground season only and so long as the undersigned is a member in good standing. The undersigned agrees not to use dirt bikes, golf carts, four-wheelers or other all-terrain vehicles on the said access road except for the purpose of entering and exiting the property.
